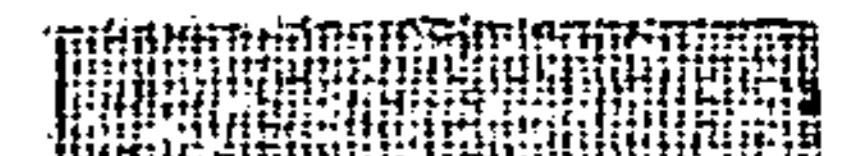

Tuesday, May 2, 2023, in Atlanta Community School District, Montmorency County, Michigan (the "District"), and canvassed by the Board of County Canvassers of Montmorency County, Michigan.

**STATEMENT OF VOTES**

The Statements of votes polled in the voting precincts of the District, at the regular election held on Tuesday, May 2, 2023, and filed with the County Clerk, and this Board, having duly examined and considered the statements, the whole number of votes given for and against the proposition reading as follows:

**ATLANTA COMMUNITY SCHOOL DISTRICT  
OPERATING MILLAGE PROPOSAL**

This proposal will allow the school district to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its revenue per pupil foundation allowance.

Shall the limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Atlanta Community School District, Montmorency County, Michigan, be increased by 2 mills (\$2.00 on each \$1,000 of taxable valuation) for a period of 7 years, 2023 to 2029, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and levied in 2023 is approximately \$19,970 (this millage is to restore millage lost as a result of the reduction required by the Michigan Constitution of 1963 and will be levied only to the extent necessary to restore that reduction)?

The statements of votes polled in the one (1) voting precinct of the District, at the special election held on Tuesday, May 2, 2023, and filed with the County Clerk, and this Board, having duly examined and considered the statements, the whole number of votes given for and against the proposition reading as follows:

**BRILEY TOWNSHIP**

**Proposal for Ambulance Millage**

*This proposal will permit the Township to levy 2 mills for the purpose of providing funds for ambulance services.*

Shall the limitation on the amount of ad valorem taxes which may be levied by the Township of Briley, Montmorency County, Michigan, against taxable property in the Township be increased by two (2) mills (\$2.00 per \$1,000 of taxable value) for a period of three (3) years, 2023 through 2025, inclusive for the purpose of providing funds for ambulance services, and shall the Township levy such millage for this purpose? If approved and levied in its entirety, this millage would raise an estimated \$149,568 for the Township in 2023.
